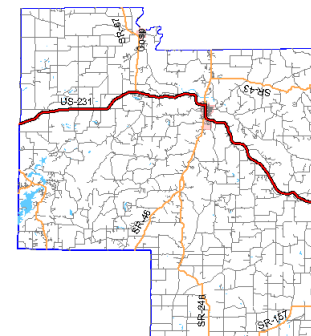

Analysis can be done at any level from state to county, block group, zip code, neighborhood, or based on any arbitrary selected boundaries. Alternately, a radius can be drawn around a site (e.g., a school, place of worship or prevention program) to be studied. The greatest power of PREV-STAT™ is its ability to zoom in on the very small geographic area!
